This agreement is between stud dog owner, Andrea B. Sheperd, owner of La Dolce Vita Farms, LLC, and bitch owner(s) _____

Terms:

1. The stud fee of \$2000.00 private contract is payable to LDV after the birth of a viable litter. Viable litter is defined as two live puppies of either sex at two days old.
2. A non-refundable deposit of \$200 is due at the time of the breeding and will be applied to the stud fee after the litter is born.
3. All veterinarian fees associated with this breeding including but not limited to collection, shipping, testing, etc, are the responsibility of the bitch owner(s) and are to be paid directly to the veterinarian at the time of the services.
4. Prior to breeding, the bitch owner(s) agree to provide LDV upon request copies of:
 - a. Pedigree
 - b. Registration certificates
 - c. Hip and elbow results with a passing evaluation
 - d. If live cover by the stud, current negative brucellosis test, rabies certificate, health certificate
5. The owner(s) of the bitch are responsible for:
 - a. Any emergency veterinary fee for illness/injury of the bitch while being kept for breeding purposes
 - b. A boarding fee of \$20.00 per day if stay extends past 8 days
 - c. All transportation expenses related to bitch arriving and returning from LDV, including a new health certificate if required

- d. Bitch owner(s) agree to have the resulting puppies eyes checked by a board certified ophthalmologist by eight weeks of age and relate the results to LDV once received. Provide copies of the certificates upon request
 - e. Resulting puppies from this breeding WILL NOT be sold to any breeding programs that are registering puppies as anything other than AKC/ASCA Australian Shepherd registrations, including but not limited to any doodle, mini, toy, pet registries. All companion puppies will be sold on a limited registration spay/neuter agreement.
 - f. Once bred, bitch will be confined to assure she is not bred by any other stud dogs by accident or intentional.
 - g. All advertising of the litter will be professional in appearance and approved by LDV before posting or printing and LDV will be given appropriate credit in the advertising out of respect for the stud dog.
6. LDV is responsible for:
- a. Keeping the bitch confined and only exposed to Marty during her stay if she is boarded at LDV Farms.
 - b. Keeping the bitch safe while staying in LDV's care; however, LDV and/or the owners of LDV Farms will not be held liable for any illness, injury or death of the bitch while in our care as we will do everything possible to prevent any incidents.
 - c. All registration papers of resulting puppies will be signed upon fulfillment of the above agreement.

There will be a \$5,000.00 fine per occurrence assessed by the stud owner to the bitch owner(s) for each/every violation of the contract above. Any disputes or legal action regarding this contract will be addressed and filed in Oklahoma County Courts.
